DAYCARE / BOARDING WAIVER

1. I represent that I am the legal owner or agent for the owner of the Pet described in the correlating application form Initial_____

2. I release LITTLE CRITTERS –BED & BISCUIT, its staff, owners, representatives, and agents from any and all liability which I or my Pet may suffer including but not limited to injury, sickness, damage or death resulting from participation in daycare, overnight boarding, or outdoor walks. 3. I represent that my Pet is in good health, is current on all required vaccinations
CATS: Feline Rhinotracheities-Calici-Panleukopenia (FVRCCP), & Rabies.
DOGS: Canine Distemper-Adenovirus-Parainfluenza- Parvovirus, Rabies & Bordetella.
Is free of fleas, ticks, and lice, and has not been ill with any known contagious viruses in the last 30 days. Initial_____

4. I understand that while my Pet is fully vaccinated that vaccines are not guaranteed and there is a small risk that my Pet may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention. Initial_____

5. I agree to allow 7 days waiting period after my Pet has had their vaccinations to allow the vaccines to reach full protection potential and to ensure my Pet has not had any negative reaction to the vaccines. Should I allow my Pet to stay at LITTLE CRITTERS – BED & BISCUIT less than 7 days after vaccination I understand that my Pet could be at risk of contracting a contagious virus/disease. Initial_____

6. I understand that although all Pets are supervised that incidents of injuries may occur from playing with the other Pets, which include but not limited to bites, scrapes, scratches, and sprains. Initial_____

7. I represent that my Pet is sociable and has not harmed or shown threatening behaviours towards any person or any other animal. I understand LITTLE CRITTERS – BED & BISCUIT reserves the right to remove my Pet from the play area and place my Pet in a separate holding area should my Pet display any unwanted behaviours. 8. I understand that LITTLE CRITTERS – BED & BISCUIT reserves the right to permanently remove a Pet from its daycare or boarding facilities at anytime.

9. I allow LITTLE CRITTERS – BED & BISCUIT staff to contact my veterinarian or any other accessible vet clinic as deemed necessary should any injuries / illnesses, require medical attention. I agree that I am solely responsible for any medical expenses acquired for my Pet.

10. I agree to disclose any previous or current medical issues or concerns of my Pet so that LITTLE CRITTERS – BED & BISCUIT staff can make a determination of suitability for daycare or boarding.

11. I release LITTLE CRITTERS – BED & BISCUIT from any liability should my Pet injure another pet or person and accept medical and legal responsibility for my pet's actions.

12. I release LITTLE CRITTERS – BED & BISCUIT from any liability should death of my Pet occur for any reason while in daycare or overnight boarding.

13. I agree to pick up my Pet prior to 3:00 pm. Should I fail to do so I understand I will be charged an extra day of boarding.

I understand that should this occur I may not be able to pick up my Pet until the following day as well as be charged additional fees for food and other supplies used for boarding for my dog.

14. I understand that drop off and pick up is permitted only during hours of operation. I understand that LITTLE CRITTERS – BED & BISCUIT reserves the right to refuse after hours pick up.

15. I agree to pay for any and all outstanding charges prior to or at time of pickup of my pet. I understand that should I not have provisions for payment at the time of pickup of my pet, LITTLE CRITTERS – BED & BISCUIT reserves the right to withhold my Pet and continue to charge for continued services and any additional fees until payment is made in full. I understand that should I fail to complete payment within 7 days of the notified due date, LITTLE CRITTERS – BED & BISCUIT will proceed with the ABANDONED PET PROCEDURE.

16. In the event that you, your emergency contact, or any other person you have authorized to us in writing does not pick up your Pet on the agreed upon departure date, you hereby authorize us to continue to provide boarding, and any additional services at your expense. If such Pet is deemed abandoned under provincial laws LITTLE CRITTERS – BED & BISCUIT will use its discretion permitted by law to follow the Abandoned Pet Procedure. Initial_____

ABANDONED PET PROCEDURE:

We will attempt to contact you by telephone and/or in writing using the information that you have provided, advising you that if your Pet is not picked up within 7 days, your Pet will be deemed to be abandoned and we will deliver your Pet to a third party adoption partner, animal shelter, or attempt to find a new owner for your dog. If you fail to pick-up your Pet for any reason, you release LITTLE CRITTERS – BED & BISCUIT its staff, owners, representatives, and agents from further liability and responsibility for your dog.
